



The total number of section of the school shall be restricted to 35 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws. 2. The school has uploaded land certificate dated 24-10-2016 land measuring 8660.58 sq mtrs, whereas name of the school is not reflected in the same. However, the school was initially granted on the same land area. Thus. The school is directed to obtain renewed land certificate as per appendix – X of affiliation bye-laws and upload the same on the school website under mandatory disclosure section. 3. The school has uploaded videography of



However, while viewing of the same it has been observed that some construction material lying in the school campus and an electrical wire has been passing through main gate of the school building. Thus, the school is directed to remove the same in view of the safety . 4. The school has not constituted the committees of "Grievance redressal Mechanism, & Sexual Harassment of Women at Workplace" as per Board norms. Therefore, the school is requested to constitute the said committees as per Affiliation Bye- Laws and furnish details on the school website. 5. The school is required to upload Mandatory Public Disclosure as per annexure - IX in the home page under distinct icon on the school website for easy accessibility by public in compliance to Board's circular no. 09 dated 21-05-2021. 6. The school has uploaded self-certification, whereas date of expiry on recognition is not reflected in the same. However, copy of the same has been uploaded by school on the school website under mandatory disclosure section. Thus, the school is directed not to remove the same from its website in future. 7. The school is required to set-up Computer, Mathematics lab library as per dimension given in Affiliation Bye-laws and upload the videography of the same on the school website under mandatory disclosure section. 8. The school is required to repairs its flooring of labs and should maintain the Toilets more hygienic. 9. The school is required to upgrade science lab with more equipment's and apparatus. 10. The school is required to appoint special educator as per Board's norm. 11. The school is required to develop its play area and improve the interior. 12. The school is required to renew all the mandatory certificates time to time. 13. The school is directed not to remove the videography link in future
